We are aware that you trust us. We therefore see it as our responsibility to protect your privacy. On this page we'll let you know what information we collect when you use our services or products, why we collect this information and how we improve your user experience. This way you understand exactly how we work.

Mount Media Solutions respects the privacy of all its users and ensures that the personal information you provide us is treated confidentially.

### Personal data we process

Mount Media Solutions processes your personal data by using our services and/or because you provide this information to us. Below you will find an overview of the personal data that we process if you become a member of our services:

- Mobile phone number
- IP Address

In case you visit our websites, the data we process is obtained by your Archive files for browsing information, as informed via the cookie policy of each of our users' websites (websites that show our ad formats). The data obtained are: URL of the website showing our ads, referral URL, IP, country, geographic area, browser and operating system.

### Particular and/or sensitive personal data.

Our products/services do not intend to collect data on users under 18 years of age. However, we cannot verify that a visitor is over 18. We therefore recommend that parents be involved in the online activities of their children to prevent the collection of information about children without parental consent. ### For what purpose and based on what basis do we process personal data

### Automated decision-making

Mount Media Solutions does not take decisions based on automated processing on matters that may have (significant) consequences for individuals. These are decisions taken by computer programs or systems, without a human being (e.g. a Mount Media Solutions employee).

## How long we keep personal information

Mount Media Solutions does not keep your personal data any longer than is strictly necessary to realize the goals for which your data is collected.

- We will your keep personal information only for as long as is necessary to achieve the goals for which we have collected it, including compliance with statutory, accounting or reporting requirements.
- To determine the correct retention period for personal data, we take into account the amount, nature and sensitivity of your personal data and the potential risk of damage caused by unauthorized use of your personal data, the purposes for which we your processing personal data and whether we can achieve those goals in other ways, and the legal requirements.
- If we your no longer need to process personal data for the purposes set out in this privacy policy, we will your remove personal information from our system.

## View, modify, or delete data

You have the right to view, correct or delete your personal data. In addition, you have the right to withdraw any consent to the data processing or to object to the processing of your personal data by Mount Media Solutions and you have the right to transfer data. This means that you can submit a request to us to send the personal data that we have with you in a computer file to you or another organization you mentioned. To ensure that the request for inspection has been made by you, we ask you to send a copy of your identity document with the request. In this copy, make your passport photo, MRZ (Machine Readable Zone, the strip with numbers at the bottom of the passport), passport number and Citizen Service (BSN) black. This to protect your privacy. We respond as quickly as possible, but within four weeks, at your request. Mount Media Solutions also wishes to point out that you have the possibility to lodge a complaint with the national Supervisor, the authority personal data.

Note that some requests to remove personal information remove your Personal account as providing user accounts (e.g. your Email address). Please also note that it is possible that we need additional information from you to your Permission to request your Request.
